**Resolution 2016-002**

**Opposition to Seismic Testing and Drilling Off the Atlantic Coast**

**WHEREAS**, the U.S. Bureau of Ocean Energy Management (BOEM) has proposed allowing seismic blasting off the Atlantic Coast from Cape Canaveral to the Delaware Bay to search for oil and gas; and

**WHEREAS**, the seismic air-guns used to search for oil and gas emit one of the loudest sounds in existence, penetrate miles into the ocean floor, and are fired every ten seconds, 24 hours a day for weeks at a time; and

**WHEREAS** seismic blasts have been proven harmful to fish, marine mammals, and other marine life; and

**WHEREAS**, the full impact of seismic testing in the Atlantic Ocean is not yet fully determined; and

**WHEREAS**, drilling, extraction, and transportation of offshore oil and gas pose a risk of spillage and leakage which could be catastrophic to the Delaware Bay, the Inland Bays, and Delaware's coastal wetlands and waterways; and

**WHEREAS**, the residents of the Town of Milton (Town), situated at the head of the Broadkill River, recognize the economic and environmental importance of a healthy and vibrant coastal environment and for the past eleven (11) years, the Town, the U.S. Prime Hook National Wildlife Refuge, and the U.S. Fish and Wildlife Service have sponsored the Annual Horseshoe Crab and Shorebird Festival to promote the public's awareness of the economic, scientific, and recreational importance of horseshoe crabs and shorebirds; and

**WHEREAS**, an oil spill in the mid-Atlantic has the potential to have a catastrophic impact on recreational fishing along the Broadkill as well as cause damage to Broadkill Beach, which is currently undergoing a \$63 million beach replenishment project;

**NOW THEREFORE**, be it resolved by the Mayor and Town Council that the Town of Milton is opposed to seismic air-gun testing and drilling for oil and natural gas in the Atlantic Ocean.

**BE IT FURTHER RESOLVED** that a copy of this Resolution shall be sent to our Congressional Representatives, the Governor, and the U.S. Bureau of Ocean Energy Management.
