WHEREAS, the Town Code requires the Town Council to fix by resolution the time and place of the public hearing and cause notice to be given via: publication not less than 15 days prior to the date of the hearing; written notice to any required municipal, county, state, or federal agency in a manner prescribed by law; and certified mail, return receipt requested, to all owners within 200 feet of the boundaries of the subject property at least 10 days prior to the public hearing; and

WHEREAS, the Town has received an application of Dogfish CVI, LLC for a rezoning of tax map and parcel no. 2-35-20.00-53.00, also known as Cannery Village Phase 3A, which entails a proposed amendment to the Town Comprehensive Plan for the same parcel; and

WHEREAS, the Town Council referred the application to the Planning and Zoning Commission on August 18, 2011;
