GRASS/WEEDS ON SIDEWALKS

Spring has sprung... and that means **GRASS!!!**

The maximum height for grass is 8". Remember to keep grass clippings off the sidewalks and out of the streets, as they can clog storm drains. Also, don't forget about the grass that grows on the sidewalks.

§ 158-1 PROHIBITS THE GROWTH OF GRASS, WEEDS AND OTHER VEGETATION UPON ANY SIDEWALK ABUTTING ANY LOT IN TOWN, AS WELL AS GRASS CLIPPINGS AND OTHER DEBRIS.

SATELLITE DISHES

As a reminder, any satellite dish, tower, or antenna are only permitted to be located in rear yards and not visible from the street. Review Town Code §220-52 for more information.

PROPERTY HOUSE NUMBERING

To follow up on the town-wide mailing in January, Town Code requires your house number to be visible from the street and be placed near the entrance of your residence. Your compliance with Town Code assists first responders in locating your property during emergencies. Please refer to Town Code § 85-15 Numbering of property.

FROM THE DESK OF THE PUBLIC WORKS SUPERVISOR

The Town contracts with the Delaware Department of Natural Resources (DNREC), Mosquito Control Section for the spraying of mosquitoes. To assist with keeping the mosquito population at a minimum, follow the below recommendations as mosquitoes breed in water:

- DISPOSE OF TIRES LAYING AROUND HOLDING WATER
- CLEAR ROOF GUTTERS OF DEBRIS
- CLEAN PET WATER DISHES REGULARLY
- DRILL HOLES IN BOTTOM OF RECYCLING CONTAINERS
- CHECK & EMPTY CHILDREN'S TOYS
- REPAIR LEAKY OUTDOOR FAUCETS
- CHANGE WATER IN BIRD BATHS FREQUENTLY
- AVOID WATER COLLECTING ON POOL COVERS
- CANOES, KAYAKS & OTHER BOATS SHOULD BE TURNED OVER
- PLUG TREE HOLES
- EMPTY WATER COLLECTED IN TARPS AROUND THE YARD OR ON WOODPILES

Sidewalk Compliance

Property owners are responsible to maintain sidewalks that are adjacent to their property and within any right-of-way area. Make sure sidewalks are free from cracks, tripping hazards, and debris, which includes loose concrete, shrubbery, limbs, grass and weeds. As required by Town Code, the Town will mail a notice to any property owner for which sidewalk repairs are needed.

A reminder to those with irrigation systems....

The State of Delaware requires the installation of a backflow device on all irrigation systems and annual testing by a certified ASSE tester. For more information, don't hesitate to contact Greg Wingo, Public Works Supervisor at 302-684-4110.
