RESOLUTION 2024-004

TO RATIFY THE RESULTS OF THE JANUARY 27, 2024, WATER SYSTEM IMPROVEMENTS REFERENDUM

WHEREAS, the Town of Milton, Delaware, owns, operates and maintains a public water system; and

WHEREAS, the Town proposes to construct certain water system improvements, being Water Main Replacement under Carey Street, Walnut Street, Magnolia Street, Mill Street and Bay Avenue (\$1,785,000); and Chandler Street Water Treatment Facility Improvements (\$579,000); and Federal Street Water Tower (\$3,850,000); and

WHEREAS, the Town had applied to the State of Delaware and received a preliminary commitment for a combined loan total of up to \$6,214,000 principal amount from the Drinking Water State Revolving Fund ("DWSRF'), to finance the total project costs; and

WHEREAS, Section 33 of the Town Charter outlines specific procedures that were followed in order to conduct a referendum and incur indebtedness;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of the Town of Milton ratifies the following actions that were completed in accordance with Section 33 of the Town Charter:

- a) In compliance with Section 33(a)(2)(A), Resolution 2023-024, entitled "To Schedule a Public Hearing on Resolution 2023-022 [To Propose Borrowing of up to \$6,214,000 to Finance Public Water System Improvements and to Order the Referendum to be Scheduled] ", was adopted on November 6,2023;
- b) In compliance with Section 33(a)(2)(B), the Town posted the public hearing notice on the Town's website, bulletin board, Town Hall, Kiosk in Memorial Park, and Milton Library on November 17, 2023; and advertised the public hearing notice in the Cape Gazette on November 21, 2023;
- c) In compliance with Section 33(a)(2)(C), on December 4, 2023, said public hearing took place, and thereafter Mayor and Town Council adopted Resolution 2023-022, entitled "To Propose Borrowing of up to \$6,214,000 to Finance Public Water System Improvements and Order the Referendum to be Scheduled";
- d) In compliance with Section 33(a)(2)(D), a notice of the time and place of the Referendum was published in the Cape Gazette on December 22, December 26, December 29, and January 2, 2024; mailed to all property owners and citizens on January 5, 2024; and posted on December

- 18, 2023 at Town Hall, bulletin board, Town website, Kiosk in Memorial Park, Milton Library; and
- e) In compliance with Section 33(a)(2)(F), the Board of Special Election was appointed on January 8, 2024; the referendum ballot was prepared by the State of Delaware, Department of Elections on January 2, 2024; and the referendum was conducted using voting machines.

BE IT FURTHER RESOLVED that said Water System Improvements Referendum took place on Saturday, January 27, 2024, at Milton Fire Department, from 8 a.m. to 6 p.m., with the Board of Special Elections then counting the absentee votes and certifying the voting totals between the machine votes and absentee votes. Results are as follows: Water Main Replacement 567 votes in support and 41 against; Chandler Street Treatment Facility 558 votes in support and 46 against; and, Federal Street Water Tower 513 votes in support and 92 against. Receipt of said certificate is hereby acknowledged and the results are hereby ratified.
