## **RESOLUTION 2024-010**

## TO REQUEST THAT DELDOT CONVERT THE INTERSECTION OF FEDERAL STREET/MULBERRY STREET/WHARTON STREET TO AN ALL-WAY STOP CONTROLLED INTERSECTION (AWSC)

WHEREAS, the Charter of the Town of Milton vests power in the Mayor and Town Council to provide for and preserve the health, peace, safety, cleanliness, ornament, good order and public welfare of the Town and its inhabitants; and

WHEREAS, the Milton Traffic Calming Advisory Ad-hoc Committee conducted research, completed a town-wide residents' survey that identified the intersection as one of the top ten traffic-related concerns, and presented a report to Town Council in 2021; and

WHEREAS, on October 3, 2022, the Town Manager presented to Mayor and Town Council DelDOT's request for the Town's viewpoint of the intersection for improvements before they complete the Traffic Impact Study (TIS) for The Granary project; and

WHEREAS, on October 3, 2022, a motion to request the developer enter into an agreement with DelDOT to design and construct future improvements to include a signal, round-about, or other control measures that will be determined by DelDOT at a later date to the intersection of Delaware Route 5(Federal Street)/Mulberry Street and Wharton Street, the developer should coordinate with DelDOT on the improvements regardless of any interim improvements made by the Town; and

WHEREAS, on March 6, 2023, Milton Town Council discussed Resolution 2023-006, as required by DelDOT, included the request that DelDOT convert the intersection of Federal Street/Wharton Street/Mulberry Street to AWSC and passed by a vote of 4-3.

WHEREAS, on April 3, 2023, Milton Town Council, by a vote of 3-3, did not "ratify" their March 6, 2023 votes that had approved the intersection conversion to All-Way Stop (AWSC); and

WHEREAS, on May 1, 2023, Milton Town Council by a vote of 6-1 voted to install the ADA compliant infrastructure without the installation of AWSC devices.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Town Council of Milton respectfully request that the Delaware Department of Transportation approve the conversion of the FEDERAL STREET/MULBERRY STREET/WHARTON STREET intersection to an all-way stop, no later than May 31, 2024.
