A note from the Mayor:

Summer has commenced, and Milton is once again bustling with activity. Councilman Edler and his team have curated an exceptional lineup for the summer concert series in the park. We extend our gratitude to all sponsors and the Milton Volunteer Fire Company for facilitating events during adverse weather conditions.

The Farmers and Artisan Market, held on the grounds of Grace Church every Friday, has resumed and is flourishing. We commend Threasa Brittingham and the Cape Community Foundation for their efforts in sustaining and expanding this event. The Milton Theatre's annual Pride event was well attended and organized despite being scaled back.

There is significant construction activity in Milton this season, as many of you may have observed. The Town's water system is undergoing numerous capital upgrades, including water main replacements, new water tower and treatment facility on Federal Street, and new water meters town-wide.

Furthermore, rehabilitation and upgrades of the Chandler Street treatment facility are also underway. These drinking water projects, along with Artesian's wastewater force main placement, will impact traffic throughout Town periodically. Please follow the Town website for updates as they occur. Artesian will soon announce the commencement date for the decommissioning of the Front Street Wastewater Treatment facility.

The Town's leaders and staff continue to work on the development of parking on Magnolia Street. With the acquisition of parcels on Magnolia Street, long range planning for the property's use is now underway.

The Town Manager and department heads are in the process of preparing the annual budget. A first reading of the budget will be made in late July, then followed by Finance Committee and Town Council review. All meeting notices are posted on the Town website.

A few seasonal reminders:

Grass and Weeds... Summer has arrived, and therefore, the grass and weeds will grow and flourish much faster. Town Code Chapter 152, entitled "Nuisances," and Town Code Chapter 158, entitled "Property Maintenance," provide requirements for grass and weeds. Height must be kept less than 8 inches, no growth or accumulation on sidewalks, curbs, or in the street, and shrubbery must be trimmed away from streets and sidewalks to prevent sight distance issues, pedestrian interference, or tripping hazards.

Solid Waste, Recycle, and Yard Waste Containers...In efforts to keep our streets and sidewalks passable, the following regulations are within Town Code Chapter 179 regarding container collection:

- Placed at the street no earlier than sunset the day prior to collection nor later than 7:00 am the day of collection; and
- Removed no later than 6:00 pm the day of collection and stored to a point at the side or rear of the structure.

<u>Water Meter Pits...</u> While planting or gardening this summer, keep in mind that all town water meter pit covers need to be kept clear of mulch, soil, dirt, plants, bushes, statuary, etc. This is to ensure easy access to the meter pit for meter readings, maintenance of the pit &/or meter, etc.

<u>Irrigation Systems</u>...The State of Delaware and Milton Town Code Chapter 215-30 entitled "Cross connection; prevention requirements", requires the installation of a backflow device on all irrigation systems and annual testing by a certified ASSE tester. Mosquito Control... The Town contracts with the Delaware Department of Natural Resources (DNREC), Mosquito Control Section for the spraying of mosquitoes. To assist with keeping the mosquito population at a minimum, please do your part in following recommendations as mosquitoes breed in water. Do your best to keep outdoor items free of standing water.
